President's Letter

Between September 15 and October 15, Ryan Place residents will have the opportunity to cast their vote for a long overdue traffic calming plan for the neighborhood. A special committee has diligently worked for several years with the City of Fort Worth on the development of this plan. Neighborhood meetings as well as website and newsletter updates have provided current information and solicited resident input on the evolving plan.



I would encourage all Ryan Place residents to attend the September 15 RPIA meeting. At the meeting, the traffic committee and City staff will do

a final presentation on the plan components. Starting now and , through October 3, the committee will coordinate neighborhood voting on the proposal. If approved by the required number of residents, the City will then begin the process of implementing the Ryan Place traffic calming projects.

It is very important that Ryan Place seize this opportunity and obtain some of the limited City funds for a neighborhood developed and sponsored traffic calming plan More detailed information about the plan is detailed in this newsletter and at historicryanplace.org.

An opportunity to implement a neighborhood enhancement project with this level of City funding won't come around very often. With only \$600,000 in program funding available for the entire City, only a limited number of neighborhoods will be able to participate. Moving forward, there will be no funding for the program in 2009. We are poised to be the first of one of few neighborhoods that will receive project funding. A vote of support by the neighborhood for the program is the final step in the process.

Please join me in supporting this comprehensive plan that will decrease neighborhood cut through traffic and, more importantly, improve vehicle and pedestrian safety on Ryan Place streets.

After three years we are ready for a vote! Thanks to all the volunteers who participated in the process and the City of Fort Worth engineers and staff – we could not have done this without you! Repair Your House With a Home Central Loan

A home that's kept in good repair is an asset to its owner and to the community. But not every homeowner has enough cash on hand to fix a leaky roof or shaky stairs, or repair things that get worn out through long use.

Homeowners in Fort Worth's Central City have a new opportunity to fix up their homes and revitalize their neighborhoods. It's called the Home Central Loan Program. It is a partnership of a local financial institution, the City of Fort Worth, and the Fort Worth Housing Trust Fund.

Home Central loans for as little as \$5,000 are available to residents of the Central City (inside Loop 820) who meet the income guidelines. Qualified applicants receive an interest rate slightly lower than market rate. Generally, a project qualifies if it helps make a home safe and habitable. Not qualifying, for example, would be patios, hot tubs and fireplaces.

To determine if you meet the income criteria for a Home Central Loan, please review the following chart:





The Ryan Place Improvement Association has devised a Traffic Management Plan for our neighborhood in accordance with the City of Fort Worth's Neighborhood Traffic Management Program (NTMP). This is a voluntary program, initiated by the residents of the community. The residents of Ryan Place will also have an opportunity to provide input to the City Staff regarding the design of the projects within the NTMP.

The primary goals of the community's plan are to:

- Increase safety and livability of the neighborhood
- Reduce speeds and cut-through traffic

In an effort to address these traffic issues, traffic circles are recommended for Elizabeth Boulevard, and chicanes are recommended for Cantey Street. The NTMP plan includes four projects and pictures follow on page 7:

- Elizabeth Blvd. three traffic circles, approved by the RPIA Board
- 2. Cantey chicanes
- 3. 5th Ave. and Ryan Place Drive 90 degree turn improvement
- 4. James at Cleburne Rd. 90 degree turn improvement

TRAFFIC CIRCLES

Traffic circles are raised islands, placed at intersections, around which traffic circulates. Circles prevent drivers from speeding through intersections by impeding straight-through movement and forcing drivers to slow down to yield. Traffic circles offer an opportunity for landscaping and they visually break up a long,

straight stretch of roadway. Collisions and other traffic accidents are reduced at intersections with traffic circles.

The advantages of traffic circles are that they reduce vehicle speeds, improved safety, and are visually attractive.

CHICANES

A chicane is a series of two or more staggered curb extensions on alternating sides of the roadway. Chicanes create a serpentine route along the street. Chicanes force drivers to slow down and to make lateral movements necessary to maneuver through the chicane.

The advantage of chicanes is that they can be used in places where traffic circles are not appropriate due to street geometry Comments and concerns should be addressed to:

Ryan Place, went to Paschal High School and Columbia University. The professional assistance offered by all these experts was invaluable.

Our project objective was to make the streets safer for pedestrians, children, bicyclists, and motorists. The Traffic Committee and the City focused on solutions to reduce vehicle speeds, reduce cut-through traffic, and prevent accidents and injuries. Numerous reports of reckless driving including cars driving into resident's front yards on Elizabeth Blvd., Willing Ave, Jessamine and Cantey were considered. Public safety was the number one priority. Additional benefits of traffic calming include increased property values and crime reduction. (The articles and studies related to public safety, increased property values, and crime reduction have been catalogued on the Ryan Place website.)

We hope that you will support the Neighborhood Traffic Management Program with a vote indicating you agree with the plan. A ballot is included in this issue of the RPIA newsletter, and the voting process has now begun. A final presentation will be made on September 15, 2008 at the RPIA monthly meeting. You may vote for or against the plan immediately after reading this newsletter. However, if you need more time you will have until October 3, 2008 to submit your ballot. Each household will get one vote. You can mail your ballot or deliver it to one of the five residences listed on the ballot.

The Fairmount Neighborhood Association leadership supports our plan and has expressed an interest in collaborating with the Ryan Place Streets and Traffic Committee to coordinate traffic calming between our neighborhoods.

Thank you for your time and we look forward to your participation in the voting process.

A Love Affair With a Neighborhood

(The following is the fourth in a series by Ryan Place resident Janie Hart, which she presented to a meeting at the Fort Worth Woman's Club in 2007. The series will continue monthly in the newsletter.)

In the early 80's community block grants became available. The Carrera marble gates at either end of Elizabeth Blvd. had been torn down in the '50's in an unwise attempt to modernize the area. We applied for money to rebuild these gates, but were turned down - we appeared too affluent. A group of enterprising young women of Ryan Place developed a Christmas tour of homes as a way to raise the money ourselves. They formed a non-profit corporation and the Candlelight Tours were born. Fortunately, there were very few Christmas Tours of old homes then. The neighborhood responded enthusiastically by volunteering as docents, roaming choirs, and anything else that was needed.

In the ensuing years the corporation has provided the funds for a reconstruction of the gates on 8th Avenue and Elizabeth, and a modified reconstruction of the gates on College and Elizabeth. The architect on the project was Larry Hoskins, who lived on Elizabeth. The corporation is currently providing antique lights like the old ones on 5th Avenue for the entire neighborhood. To date, the neighborhood, through the Candle Light Tour, has raised \$263,000 for gates, lights and many other projects.

About that time the houses along Elizabeth Blvd. were included in the National Register. A young graduate student did the research on the homes and helped the residents achieve this mile-

The City then instituted a Historic Zoning Designation. I did the proper research to get a historic designation for our home and a City Landmark medallion for it.

Documents show the land belonged to Joshua Ellis as far back as 1855. It became known as the J. N. Ellis survey, passed through many hands, and was sold to John Ryan in 1909. In 1911 it became the Ryan Place Addition. The lots (the house is situated on two lots) were sold to James D. Davis in 1919, but the house was on the tax rolls in 1918. This is so far a mystery. I have documentation indicating that Wylie Clarkson was the architect.

In any case, the first homeowners were Jane and James D. Davis. He was a partner in Stonestreet-Davis Clothing Store. Their reputation for the finest in men's clothing was known throughout Texas and Oklahoma. The Davis's lived in the home until after the death of James. In 1942 it was sold to George and Agnes Hurd. George was a Vice President of Fort Worth Nation Bank. In 1963, after George's death, Agnes sold the home, which was briefly occupied by another family, and we, the 4th owners, bought it in 1966.




