Option: Private security patrol

A review of bids from two security companies confirmed that Texas Industrial Security (TIS) offers the best price for more security patrol hours. Services offered by each company were essentially the same:

- Mobile patrol coverage for subscribed residents.
- Vacation patrol checks and officer escort to residence entry upon request.
- Residents with a residential security alarm system would have the option of listing TIS as a secondary contact. If so, and a resident's alarm system were triggered, TIS would be notified, as well, to ensure that the TIS officer would be alert for suspicious activity
- TIS provides 24 hour, 7day/week dispatch and patrol officers are issued a mobile phone.
- Security report presented at monthly neighborhood meeting.

TIS patrol service for 10 hours/day, 7 days/ week, with a minimum of 150 subscribers would cost \$111.14 per residence per quarter (\$37.04/month). Patrol service for 8 hours/ day, 7 days/week, with a minimum of 150 subscribers would cost \$88.87 per residence per quarter (\$29.62/month). The neighborhood would have input on which hours would be patrolled and the patrol schedule would vary.

TIS would bill RPIA monthly and RPIA would then bill subscribing residents quarterly; PayPal would be available for payments. Each subscriber's one year contract would be with RPIA.

Fifty residents have contacted **Eric Livesay** to subscribe for security patrol. When 150 subscribers have committed, we will contract with TIS and they will begin patrolling within a week. To subscribe or learn more, contact Eric Livesay at ryanplace@hecate.com or 817-879-7155.

Contractors will be in Ryan Place in March to maintain alleys that are part of the City's alley maintenance program. Committee will be reviewing bids to determine a cost for homeowners who are interested in installing security lights, surveillance cameras, and/or gates in their alleys.

Block Captains -

Officer **Joel Stary** will meet with Block Captains and other interested residents on Saturday, March 10th, 9 am, at 2620 College Ave. to instruct on securing alleys through maintenance, lighting, surveillance cameras, and gates. The 2600 block alley between College Avenue and South Adams Street sets the standard and has been maintained by **Bill Vaughan**.

Code Blue -

Six residents have completed the first portion of Code Blue training.

Additional recruits are needed, especially residents who are at home during the day.

Railroad Quiet Zone Update

The quiet zone became active Saturday, February 4th, but there have been some malfunctions with the Wayside Horn System at the Lipscomb crossing. This is the first use of this system in Fort Worth and the manufacturer has come to the location to investigate for errors. Federal regulations require the train engineer to sound the locomotive horns if a pedestrian, vehicle, or construction worker is observed in the train track right-of-way. Two signs in the right-of-way alert engineers of a quiet zone: a flashing sign that indicates that the barricades are working properly and a one-foot square "QZ" sign. If the sign is not flashing, the engineer is to sound the locomotive horn.

Behind the Scenes



RPIA MEETING MINUTES

Minutes of the RPIA meeting are published after they are approved by the Board; the Minutes are published as approved and <u>are not edited</u> for publication in the NEWSLETTER.

The RPIA meeting on Monday, January 16, 2012 at Mitchell Hall, St. John's Episcopal Church was called to order at 7:04 pm by President John Kline. Board Members present were President John Kline, 1st Vice President Mariann Taccia, 2nd Vice President Kurt Nielsen, (Acting) Secretary Olivia Flynn, Street Directors John Belknap (8th, James, Stanley), Rick Tucker (Ryan Ave.), Mike Lindner (Willing Ave.), Suze Diesel (6th Ave.), Katie Shumate (5th Ave.), Lin Parham (Ryan Place Dr.), Chris Ebert (So. Adams), Laura Crews (College Ave.), and Joan Kline (Alt. Elizabeth Blvd.). There were no new neighbors at the meeting; approximately 35 residents attended the meeting.

Michelle Gonzales from the City of Fort Worth offered a Power Point presentation on the Public Art project for the roundabout at Elizabeth Blvd. and 5th Avenue that included the program goals, panel members, and the credentials of the artist, Alice Bateman, who was then introduced. Ms. Bateman explained her conceptual process for the project and outlined the construction phase, pointing out that the art is expected to be completed in the spring of 2012 and will be maintained by the City.

Neighborhood Police Officer Joel Stary was joined by Sgt. Kathi Jones of the FWPD. Officer Stary reported that crime has increased in Ryan Place and he expects it to remain high for the next couple of months, due in part to people reporting crimes that had not been previously reported. Officer Stary commented on a recent domestic disturbance on 8th Ave. (which did not involve Ryan Place residents), several graffiti incidents in Fairmount, thefts, trespass issues, and confirmed that in six of the eight burglaries in Ryan Place in January, the house/garage/vehicle was not locked.

 1^{st} Vice President Mariann Taccia presented RPIA's 2012 Strategic Goals as:

- Crime Prevention Alley security through clean up, lighting, locked gates, Crime Watch signs; Vehicle ID stickers for Ryan Place residents; and uniform curb house numbers for all of Ryan Place. Laura Crews will Chair Crime Prevention Committee and promote Code Blue program in the neighborhood, for which there are several applicants. The PID relating to neighborhood security will be reconsidered.
- 2. Improvement and beautification of Ryan Place (Triangle) Park
- 501(c)(3) Tax Status for RPIA Pamm Cox is working on the legal process; Kurt Nielsen will develop fund-raising initiative.

Joan Kline urged those present to weigh the value of Crime Watch signs on alley gates and on residential properties against the "sign pollution" that they would entail.

2nd Vice President Kurt Neilsen reported that the trash receptacles to be installed in Daggett Park were delayed, but will be installed later this month; he asked for help installing them.

Treasurer Ross Vitek has resigned; VP Mariann Taccia nominated Olivia Flynn to complete his term in 2012. Motion seconded by Kurt Nielsen; no discussion; Board approved.

Committee Reports:

Katie Shumate announced that there will be a Youth Committee social in February.

Mariann Taccia reported that in February eighteen streetlights will be installed by TPW on Ryan Ave., Willing Ave., and 6th Ave., which will complete lighting of those streets. There are 53 more lights to be installed and Councilman Joel Burns will work with CCRP to formulate a plan.

Katie Shumate stated that the Historic Overlay Committee will report its three proposed options in the February Newsletter. Mariann Taccia asked when the last committee meeting was held; Katie Shumate said November. Ms. Taccia asked if respondents to the HO survey who had indicated a desire to serve on the committee had been notified; Ms. Shumate replied that they had, but none had come to the meeting.

President John Kline mentioned that several streets in Ryan Place are being reconstructed. He also announced that each Street Director is expected to recruit ten new Sustaining Members for RPIA. Director Katie Shumate objected, stating that if she had known she would have to solicit funds, she would not have accepted the Street Director position. Ms. Shumate requested formal job descriptions for Board Members.

President Kline remarked that combining the RPIA Board and general meetings as well as providing financial reports is to accomplish a policy of transparency.

Clean Alley Initiative – When asked about priorities for alley security, Officer Stary stated that first, alleys should be clean and clear. Second, lighting will deter criminal activity, and third, closing the alleys with gates will be useful.


Berry Street Initiative – Linda Clark reported that the City is still working with Wal-Mart on the possibility of variances for a "suburban model" at the corner of Hemphill and Berry St.

Mariann Taccia offered information on the recently damaged gate at the corner of Jessamine and 6^{th} Avenue. According to the City, there are no funds to rebuild the structure; Ms. Taccia will recommend to CCRP that they request bids to be submitted and suggested that RPIA and CCRP might fund it, but a decision would be made after the rebuilding cost is determined.

Meeting was adjourned at 8:24 pm.

Cupcake Study — A Progress Report

As promised back in the summer, we have been hard at work testing as many cupcake opportunities as possible. From the TCU Kroger to Manhattan it was nothing but hard work. As with any scientific study there has to be a standard by which all test samples are compared. The official standard is the Magnolia Bakery's (401 Bleecker Street, New York City) Vanilla Cupcake with Traditional Vanilla Buttercream Frosting. (Say you can't get to New York's West Village? Just pick up the Magnolia Bakery Cookbook at the Barnes & Noble; see pages 60 and 81 for the recipes.) However, some members of the research team may have been using the Chocolate variation.

As with snow cones, we have evaluated store-bought cupcakes using the same criteria: freshness, convenience, value, and flavor. I don't know if decoration should be considered in our judging, but unfortunately sometimes the visual sense takes over.

Nothing can beat the value or convenience of selecting a clam shell package of six cupcakes at the TCU Kroger. But cupcakes should be about more than just convenience. Cupcakes should be as special as the occasion to eat them. Judging solely on convenience would not yield an outcome worthy of a Cupcake Study. Therefore, we had to broaden our search to areas on the other side of the Clear Fork of the Trinity River.

J Rae's Cheesecakes on Foch Street was our first stop. Beautiful pink boxes with ribbons (by request) certainly made the cupcakes look special; helpful staff were glad we were there. Cheesecakes must be their specialty.

Harper's Blue Bonnet Bakery received several extra merit points for its adaptive reuse of a historic church on the brick section of Camp Bowie. Its cupcakes were seasonally and festively decorated. A very good value. Many other baked items available. (In the interest of full disclosure, Blue Bonnet Bakery made our wedding cake 45+ years ago. It was very good.)

Red Jett Sweets is a food truck! Its location changes daily in response to customer needs. Food trucks once only served construction site workers. Now they seem to be everywhere. We caught up with the Red Jett at 2509 Weisenberger Street, the Food Truck Park a couple of blocks north of Montgomery Plaza. Cupcakes were judged at 90% of our study standard. Probably not as convenient as the Kroger unless the Red Jett Sweets truck happens to drive up to your house and you are hungry for a cupcake!

Valentine's week we were back in New York City. Our first stop was the Grand Central Station location of the Magnolia Bakery outlet. The official Cupcake Study standard again reached a score of 100%. Even with the discount for convenience. A special cupcake for a special place.

Every street will be safe for traffic movement with curb and gutter and a smooth riding surface and each street will have generous and safe sidewalks for pleasant strolling


The neighborhood will have a clean appearance, free from visual litter, and it will be crime free.
